## 尚志社後援会会則（抜粋）

### 第2章 目的および事業

第3条 後援会は、公益財団法人尚志社の設立趣意に協賛し、これを後援することを目的とする。

第4条 本後援会は前条の目的を達成するため、次の事業を行う。

1. 公益財団法人尚志社に対する資金の寄贈
2. その他目的達成に必要な事業

### 第3章 会 員 資 格

第5条 公益財団法人尚志社の設立趣意に賛同する者は、本会の会員になることができる。

第6条 後援会会員は、第8条規定の後援会会費を納入する。

第7条 後援会会員は本人から退会の申し出のある場合、会員の資格を失う。但し、再入会を防げない。

### 第4章 会 費

第8条 後援会会費1口毎月300円也とし、1口以上負担するものとする。会費の払込みは原則として、半年分又は1年分を一括前払いするものとする。

第9条 後援会に払込まれた会費は諸経費を差引いた後、毎年1回一括して公益財団法人尚志社に寄贈する。

## Shoshisha Foundation Supporters' Association

### ○ Purpose of the Establishment

Following the establishment of the Shoshisha Foundation, a public interest incorporated foundation, the Shoshisha Foundation Supporters' Association was established in June 1960. To do our share of the task of continuing the legacy of Chobei Takeda V (Wakeiou) and to play our part in providing the scholarship program, we invite voluntary donors to contribute whatever amount they can afford and then we offer the contributions towards the scholarship funds for the Shoshisha Foundation, a public interest incorporated foundation.

### Bylaws of the Shoshisha Foundation Supporters' Association (Excerpt)

#### Chapter 2. Purpose and Activities

##### Article 3.

The purpose of the Supporters' Association shall be to assent to and support the purpose for which the Shoshisha Foundation, a public interest incorporated foundation was established.

##### Article 4.

The Supporters' Association shall carry out the following activities to achieve the purpose set forth in the preceding Article:

1. To donate funds to the Shoshisha Foundation, a public interest incorporated foundation, and
2. To carry out such other activities as may be required to achieve the purpose of the Supporters' Association.

#### Chapter 3. Eligibility for Membership

##### Article 5.

Anyone who agrees with the purpose for which the Shoshisha Foundation, a public interest incorporated foundation, was established may become a member of the Supporters' Association.

Article 6.

The members of the Supporters' Association shall pay membership fees as stipulated in Article 8 below.

Article 7.

If a member of the Supporters' Association requests the cancellation of his/her membership, he/she shall lose his/her membership. However, he/she shall not be prevented from re-applying for membership.

#### Chapter 4. Membership Fees

Article 8.

The unit of the membership fees for the Supporters' Association shall be three hundred yen (¥300) per month and the members shall pay more than one unit of membership fees. As a general rule, a lump-sum payment of the membership fees shall be made in advance on a semiannual or annual basis.

Article 9.

All membership fees paid to the Supporters' Association, less expenses, shall be donated annually to the Shoshisha Foundation, a public interest incorporated foundation.
